

Just Mercy is a 2019 American biographical legal drama film co-written and directed by <u>Destin Daniel Cretton</u> and starring Michael B. Jordan as Bryan Stevenson and Jamie Foxx as Walter McMillian.

The film explores the work of young defense attorney Bryan Stevenson who represents poor people on death row in the South. Featured is his work with Walter McMillian, who had been wrongfully convicted of the murder of a young woman. The film is based on Stevenson's 2014 eponymous memoir, in which he explored his journey to making his life's work the defense of African American prisoners.
